


MCE is a Community Choice Aggregator (CCA)

Local Governments become the power-purchaser for their communities, pooling electricity demand of residents, businesses, and municipal customers to buy greener power, and offer choice to customers.







Energy Savings Programs

\$4.1 M program funded through Public Purpose Charge

No-cost energy assessments for multifamily properties and businesses

Valued at \$3,000 - \$5,000

Cash rebates

Averaging 25-60% of project costs

No-cost direct installs for multifamily tenant units

On-bill financing loans



60,625 metric tons of greenhouse gas reductions

Equivalent to:



Eliminating carbon emissions of 12,763 cars for one year



The carbon sequestered by 49,693 acres of US forests in one year



Eliminating the energy use of 5,531 homes for one year

Climate Action Plan Progress

- County of Marin meet greenhouse gas goals in 2012 - eight years ahead of schedule!
- Initial goal: reduce countywide emissions to 15% below 1990 levels by 2020
- New goal: reduce countywide emissions to 30% below 1990 levels by 2030



Competition Drives Change



- Community Choice expanding to cities & counties throughout CA
- New 'green' power supply option to soon be offered by Investor Owned Utilities including PG&E
- SB 350, the Clean Energy & Pollution Reduction Act
 - ➤ Increases the Renewable Portfolio Standard (RPS) to 50% by 2030 and doubles energy efficiency in California by 2030.
