## What members can expect to receive from LGSEC:

1. Prompt access to paid membership benefits such as: the membership portal, discounted tickets to LGSEC forums, webinars, newsletters, monthly regulatory engagement calls, and informing regulatory filings by participating in working groups.
2. Have LGSEC Staff and Board members respond promptly to questions or concerns.
3. Receive timely and relevant updates on regulatory proceedings that impact local governments' role in reaching California's climate and energy goals.
4. Be reimbursed up to \$250 in travel expenses for attending an in-person LGSEC forum located 250+ miles from one's place of residence.

## What LGSEC expects to receive from members:

1. Provide updated contact information in the event of a staff change within the member agency.
2. Pay membership dues within 90 days of a member's anniversary date.
3. Participate in monthly regulatory calls, working groups, LGSEC forums, webinars, member portal, and other programmatic activities.
4. Provide feedback on surveys, programmatic events, and other activities.

# Membership Dues Policy

Last Updated February 2022



## Active Membership

Membership is active for one calendar year, measured from the date in which an application was received for LGSEC membership. This date is referred to as the “anniversary date”.

## Payment Cycle

- Active members shall pay their dues annually. Note that membership dues increase approximately 3% each year.
- Members have the option to change their billing date to match their budgeting, i.e. based on a fiscal year.
- Invoices for membership dues are sent out on a quarterly basis during the quarter of their anniversary date.
- Invoices are sent through the NetSuite financial system and can be paid via ACH or check made out to CivicWell. Our mailing address is PO Box 188800, Sacramento, CA 95818.
- To maintain membership status, membership dues must be paid within 90 days of the anniversary date. Payments made after this time will be considered a “late payment”.

## Late Payment

If a Member is more than 90 days delinquent, they will no longer receive membership benefits including but not limited to:

- Access to members’ portal, member newsletter, and regulatory calls
- Discount rates for LGSEC forums
- \$250 travel reimbursement for attending an in-person LGSEC forum located 250+ miles from ones’ place of residence
- Committee, working group or board participation
- Inclusion of member’s logo on the LGSEC website and other materials

## Renewed Membership

To be reinstated, members shall pay their annual membership dues in full and a new anniversary date will be set.
